ORIGIN: Belgium, France, India, UK

GENERAL The product shall be prepared from fresh sound raw material that is free from all toxic residues and taints and shall comply with all current UK/EU Food Legislation. The product is intended to be used as ingredient that is further processed and heat-treated before final consumption (minimum of +75°C for 30 seconds).

INGREDIENTS Sage 100% Declare as: Sage
(*Savia officinalis*)

PROCESSING Sage is delivered and inspected upon receipt. During processing the sage is inspected, washed, chopped, inspected and frozen (-18°C or below) and stored in bulk at -23°C or below until required for packing.

PACKING During packing, the sage is inspected before weighing and filling into blue poly lined cartons. The cartons are Best Before and Production date coded, checkweighed and metal detected, palletised and stretch wrapped before being returned to store at -18°C to await despatch to the UK at -18°C.

DEFINITIONS OF DEFECTS

Clumps

These are where several pieces are frozen together which cannot be readily separated without causing damage to the product.

This includes any material not derived from the sage plant nor defined as EVM, such as insects, pieces of insects, wood, glass, stones, metal, sand, grit, plastic or any other material which will render the product unacceptable.

Stalk


Sage stalk, with no leaf attached.

CARTON LINERS Blue food grade polythene liner of a minimum thickness of 30µm.

CARTONS Corrugated fibreboard of glued construction, no metal staples to be used. Shall be sealed using blue adhesive tape.
