ORIGIN: China

**GENERAL** The product shall be prepared from fresh sound raw material that is free from all toxic residues and taints and shall comply with all current UK/EU Food Legislation. The product is intended to be used as ingredient that is further processed and heat-treated before final consumption (minimum of +75°C for 30 seconds).

**PROCESSING** Onions are delivered fresh and peeled to the factory, each load is sampled and assessed for foreign material and physical defects. The load is then washed, cut, roasted in rapeseed oil, pureed, poured into moulds, frozen (-18°C or below) and stored in bulk at – 23°C or below.

**PACKING** During packing the onion roasted puree tablet are inspected before weighing and filling into blue poly lined cartons. The cartons are Best Before and Production date coded, check weighed, metal detected, palletised and stretch-wrapped before being returned to store at  $-23^{\circ}$ C to await despatch to the UK at  $-18^{\circ}$ C.

### **DEFINITIONS OF DEFECTS**

#### **Foreign Material**

This includes any material not derived from the onion plant nor defined as EVM, such as insects, pieces of insects, wood, glass, stones, metal, sand, grit, plastic or any other material which will render the product unacceptable.

#### Extraneous Vegetable Matter (EVM)

Vegetable material derived from the onion plant other than the onion flesh e.g. pieces of leaf etc but does not include skin from the cloves. Vegetable material not from the onion plant will be counted as Foreign material.

**ORGANOLEPSIS** (Carried out on a thawed sample.)

- **<u>COLOUR</u>** Light brown to brown colour, consistent with the roasting.
- **FLAVOUR** Full characteristic roasted onion flavour, lacking bitterness.
- **TEXTURE** A smooth homogenous puree free from large piece of un-milled onion.

### ANALYTICAL N/A

**WEIGHT CONTROL** The product shall be packed to minimum weight.

**METAL DETECTION** All cartons shall be passed through a metal detector. The system shall be tested at least every 2 hours using ferrous, non-ferrous and stainless-steel test pieces.

**BEST BEFORE DATE** The product shall be twenty-four months following the month of packing. Minimum BB date on delivery: 6 months.

**TRACEABILITY INFO** Production date or Lot number printed on the label as well as customer order number and/or delivery date.

**STORAGE CONDITIONS** Keep frozen at - 18°C at all times.

**<u>CARTON LINERS</u>** Blue food grade polythene liner of a minimum thickness of 30µm.

**<u>CARTONS</u>** Corrugated fibreboard of glued construction, no metal staples to be used. Shall be sealed using blue adhesive tape.
